

Bhopal Medical Appeal

The Appeal was launched in 1994 to set up and fund the Sambhavna Clinic in Bhopal, which provides free medical care to survivors of the Union Carbide gas disaster. Started as a project of the Pesticide Action Network UK, it became an independent charity in 2007. The Clinic says "To date we have treated more than 30,000 people. We have pioneered effective treatments combining conventional medicine with traditional Indian herbal therapy, yoga breathing and massage. We educate local communities about health issues and have helped them to fight for clean water. We have won many humanitarian awards, but the need in Bhopal is still intense – 120,000 people are still chronically ill; some poisoned by the chemically contaminated water; one victim of the disaster is still dying every day". Your support enables the Clinic to provide vital treatments and medicines, and to expand our work with peoples affected by chemical disaster.
